### FULL PLACEMENT OF RIGHTS ISSUE SHORTFALL

The company is pleased to announce that the total balance of the shortfall from the rights issue which closed on the 16<sup>th</sup> October 2009 has been placed to investors.

An interim allotment will be made today and the number of securities for which quotation is sought is 53,240,817 ordinary fully paid shares.

The capital raised from the rights issue following final allotment of the shortfall will be a total of **\$8,025,191** before issue costs.

**“The successful finalisation of this rights issue now provides the company with a strong capital base to fund a series of aggressive exploration programs on the Barlee Gold Project. In previous drilling campaigns we have had numerous high grade, shallow gold intersections and our exploration objective is to develop a suitable shallow, high grade gold resource to support a processing operation.**

**A 10,000 metre RAB and RC Drilling program is currently underway on site with assay results anticipated in December this year.**

**We are also calculating an initial JORC resource for the Halleys East mineralised zone and our focus will be on increasing this resource base through a comprehensive regional exploration program “ Darryl Harris said.**
